#### Notes to Accompany Table:-

**Note 1** Interim 1 P2501 will be processed one day later (Tuesday 2<sup>nd</sup> April 2024) after the Easter Monday Bank Holiday (1<sup>st</sup> April 2024). The payment date will be unaffected (Friday 5<sup>th</sup> April 2024).

**Note 2** Interim 1 P2503 will be processed one day later (Tuesday 28<sup>th</sup> May 2024) after the Spring Bank Holiday (Monday 27<sup>th</sup> May 2024). The payment date will be unaffected (Friday 31<sup>st</sup> May 2024).

**Note 3** P2509 Final **payments** will be made on Friday 27<sup>th</sup> December 2024, after Boxing Day (Thursday 26<sup>th</sup> December 2024). The processing date will be unaffected (Thursday 19<sup>th</sup> December 2024).

**Note 4** Due to P2513, week 52, being 9 days, there will be an Interim 4 to be processed on 31<sup>st</sup> March 2025 with payment date being 4<sup>th</sup> April 2025.
